COMPOSITION/INFORMATION ON INGREDIENTS

Active Ingredient: Nature identical pheromones for the insects *Tribolium spp*, *Lasioderma serricorne* and *Trogoderma spp*.
Product Description: Polyolefin rigid structure and lid attached to a PVC container holding dispenser of the mixed insect pheromones as well as combination of plant extracts and purified hydrocarbon thixotropic agent for the attraction and containment of the target insects.
Product Function: Insect attraction and containment for the purpose of monitoring the target species
